

**2018 WABASHA COUNTY FARMERS UNION
DON TENTIS MEMORIAL
SCHOLARSHIP GUIDELINES**

ELIGIBILITY

1. Applicants must be completing their final term or have completed their final term of their senior year in high school or be a nontraditional student currently enrolled in a college program of study.
2. Applicants must have plans to attend or be currently enrolled in a post-secondary institution (technical or trade schools, community colleges, state universities or private institutions).
3. Applicant and/or applicant's immediate family must be a Minnesota Farmers Union member who is in good standing and residing in Wabasha County.

APPLICATIONS

1. Applicants must complete the Farmers Union Scholarship Application, Essay and have two letters of reference returned to: Bill McMillin, Sec/Treas. Wabasha County Farmers Union, 59751 Hwy. 42, Kellogg, MN 55945 by the application deadline.
2. Application requests should be sent to the above address.
3. Applications must be completed by the person to whom the scholarship will be awarded.
4. Late applications will not be accepted. Applications must be in the possession of Bill McMillin by 5:00 p.m., Friday, **March 23, 2018**.
5. Applications will not be returned to the applicant.
6. Minnesota Farmers Union reserves the right to print any portion of the winning applicant's scholarship essay in *Minnesota Agriculture* and in local papers.
7. Applicants must have two people (non-family members) write letters of recommendation. The writer must mail his or her letter of recommendation to Bill McMillin, Wabasha County Farmers Union, 59751 Hwy. 42, Kellogg, MN 55945 so that it is received by the application deadline.

SELECTION

1. A committee will review all eligible applications received by 5:00 p.m., Friday, **March 23, 2018**.
2. The committee will reach its decision by **May 4, 2018**.
3. The committee will consist of the President of Wabasha County Farmers Union, the Secretary/Treasurer of Wabasha County Farmers Union, two Wabasha County Farmers Union members and the Wabasha County Field Staff Representative.
4. Applicants who had previously not applied or who have applied but not received the scholarship will be given first priority.

COMPENSATION

1. One \$500 scholarships will be given to a Wabasha County Farmers Union student.
2. The winner of the scholarship will be notified in writing and featured in *Minnesota Agriculture*.
3. The scholarship will be paid in full to the applicant's institution upon the following:
 - The person maintains a grade point average at or above a 2.5 in high school, as well as at the completion of their first semester of higher education.
 - The person provides proof of the above to the County Secretary/Treasurer.
